

## 11.19 / Weapons on University Property

(Takes Effect July 1, 2017)

# Purpose:

It is the policy of the Kansas Board of Rege(htsreinafter referred to as Board), to the extent permitted by law, to allow conceed carry of handguns and prohipossession of other weapons and open carry of firearms on the University campush sets forth. Wichita State University (hereinafter referred to as University) policith regard to the pasence of weapons on University property.

### Preamble:

In view of the enactment of the Kansass@eal and Family Protection Act, subsequent amendments and Board policy, the Board hascteideeach state University to develop and follow policies and procedures for the sptessession and storage of lawfully possessed handguns and determine whether and to whateheatherwise lawfluy possessed concealed handguns will be prohibited in any univiews buildings or areas of buildings.

## **Policy Statement:**

- A. Beginning July 1, 2017, any individual who2's years of age or older and who is lawfully eligible to carrya concealed handgun in Kansaslshot be precluded from doing so on the Wichita State University campusept in buildings and public areas of buildings for which adequate security measuresprovided, as restried in this policy or Kansas Board of Regent's policand except as otherwise prohibited by law.
- B. There are no University buildings that habeen designated as gun-free with permanent adequate security measures university may designate a specific location as temporarily gun-free, with appropriate signage, and use temporary adequate security measures after submission and appropriate Governance Committee of the Board. Appropriate notice will be given whenevalue temporary designation is made.
- C. Each individual who lawfully possesses and gun on campus shall be wholly and solely responsible for carrying, storing and that handgun in a safe manner and in accordance with the law, Board policy and the sity policy. Nothing in this policy shall be interpreted to requiindividuals who lawfully possess a handgun to use it in defense of others.
- D. Possession of weapons, other thanceated handguns, anywhere on any campus location shall be prohibited. This includes open carry of any weapon, including a handgun or handguns. Every entrance to each building and facility at any campus location shall be conspicudy sposted with appropriate indicating that openly carrying a weapon into that building or ility is prohibited. Additional signs may be posted as appropriate.

#### Definitions:

- 1. Weapons, firearms, explosives and other habours objects or substances covered by this policy shall include, but note limited to, the following:
  - (a) Any object or device which will, is designed or may be readily converted to expel bullet, shot or shell bullet action of an explosive or other propellant;
  - (b) any handgun, pistol, revolver, rifle, shotgunothrer firearm of any nature, including those that are conceal or openly carried;
  - (c) any BB gun, pellet gun, air/C'02 gun, blow gun any device, such as a Taser, which is designed to discharge electric darts the r similar projectiles; however, personal self-defense stun guns that note th
  - (d) any explosive, incendiary or poison gas (%)mb, (B) mine, (C) genade, (D) rocket having a propellant charge of more than founces, or (E) missilleaving an explosive or incendiary charge of more than ¼ ounce;
